In exercise of the powers conferred by the Calicut University Act, 1975 and Calicut University (alternative arrangement temporarily of the Senate and the Syndicate) Ordinance, 2017 (Ordinance 24, dated 21-11-2017) of Government of Kerala, the following persons in addition to the ex-officio members are nominated by the Govt. of Kerala vide reference cited 2nd, to exercise all the powers and functions of the Senate and the Syndicate for a period of six months or till the reconstitution of the Senate and the Syndicate in accordance with the provisions of

the Calicut University Act, 1975 (5 of 1975) whichever is earlier and thereby the University has formally constituted the body to exercise the powers and functions of the Senate and the Syndicate of the University of Calicut as follows:

- The Pro Vice Chancellor
- The Secretary to Government, Higher Education or an Officer not below the rank of a Joint Secretary nominated by him.
- The Director of Public Instruction
- The Director of Collegiate Education
- The Secretary to Government, Information Technology Department or an Officer of the Information Technology Department not below the rank of a Joint Secretary, nominated by him.
