### Order No. A6/27913/2015/TC dated 16-1-2018

Decision in this regard is to be taken by the Departmental Promotion Committee on merits of the case. As the objection filed by Smt. E. R. Usha is not legally sustainable, the same cannot be considered without a decision from the DPC.

No other objections were received within the stipulated time. As the time fixed for filing objections/ petitions has been over, the provisional seniority list of Senior Superintendents as on 1-11-2017 published as per order under reference is hereby finalized in accordance with the general principles, norms, Govt. Orders and relevant statutory provisions in Kerala State and Subordinate Service Rules 1958.
